What I want to transmit to all of you is WHAT information that Facebook, Craig's List and Yahoo Mail and other online accounts save on every users account and the police or anyone with a subpoena can access personal and private information.

I just received discovery via a subpoena in one of my cases and I was amazed how much information is saved and stored by these online social networks and disclosed.

This is what Facebook disclosed.

1. User Basic Subscriber Information (BSI) it includes
 - a. User ID
 - b. Email address
 - c. Date and Time Stamp of Account Creation
 - d. Most Recent Logins
 - e. Registered Mobile Number
 - f. Verification of public or private view.

2. User Neoprint (is an expanded
 - a. Profile Contact Information
 - b. Mini Feed
 - c. Status Update History
 - d. Shares
 - e. Notes
 - f. Wall Postings
 - e. Friends List
 - f. Friends Facebook IDS
 - g. Group Listings
 - h. Future and Present Events
 - i. Video Listings

3. User Photoprints
 - a. all photos that have been uploaded by the account user

4. Group Contact Information
 - a. the Creator, Administrator and current status of the group

5. Private Messages
 - a. saved on the database, unless deleted by the user.

6. Internet Protocol (IP) Address Logs. (This is YOUR COMPUTER ID Number and can be traced back to your computer. Internet computers identify each other by use of IP address. (Just like a phone number)

Be careful WHAT you put online and don't be surprised if your information is sold to advertisers and marketers. Did you ever wonder WHY you get emails just after You SEARCH for anything on one of the search engines and now FaceBook, Twitter, and other Social Networks.

Protect your privacy and information.

- Your information is being shared with third parties

I. Introduction

The terms and conditions below describe the terms on which Facebook, Inc. ("Facebook" or "us") may provide certain information about you to certain third parties ("Developers") who have developed applications that use information from the www.facebook.com website (the "Facebook Site").
